Exterior Mural Call- An Ongoing Opportunity for Public Art

PROJECT OVERVIEW: BAKERS PLACE

We are pleased to announce an open call for the creation of two large-scale art murals. The development firm, The Neutral Project, and the non-profit organization the Madison Public Art Project have teamed up to create an exciting new opportunity. A rotating mural wall, and permanent mural wall will be created at this new development site which will offer ongoing opportunities for artists. Exterior Mural 1 will be updated every 5-7 years.

The mural walls will be managed by the Madison Public Art Project with the art submission timeline listed. This is a professional opportunity for creatives to have their artwork featured at public spaces. The intention of these walls will offer professional opportunities for artists, and to engage visitors and residents. This building is located at 849 East Washington Ave. The first mural wall dimensions are 20' tall x 38' wide. The second wall is 20' x 13'. A plaque including the artist's name, mural title, and project information will be installed.





MORE INFORMATION

849 East Washington Ave. Madison, WI

Bakers Place is a 206-unit market rate development consisting of a 14-story residential building with 206 units and a full restoration of the existing bakery building. This new building will be situated on the former site of the Gardner Bakery on East Washington Avenue which closed in 2019. Famous for its bread and buns, the original bakery originally opened in 1928 and served the neighborhood for 90 years. The building pays tribute to the site in the architecturally significant details by renovating the original structure of the bakery and re-purposing it into lofted residential units and a future new bakery. The construction of this building was built to the LEED certification using mass timber construction which reduces carbon emissions by 42%. Less emissions reduces the overall carbon footprint for our planet.

Mural 1: Explain how your art will welcome people to this new site and reflect the history of the neighborhood. The work may draw in elements from nature and show the beauty of the natural world. Mural 2: Please explain how your design will honor the past, present, and future of this site and community through the theme of sustainability. The art may inspire greater awareness and care for our overall environment.

Colorful and bright interpretations of these narratives are welcomed. Public art is a powerful catalyst for building community pride and bringing people together. These murals will enliven the Capitol East District infusing new creative vitality into our city landscape.

PROCESS

Artist submissions will be reviewed by a mural selection committee. This panel will identify three semi-finalists who will be paid an honorarium to develop specific renderings for their proposals. These artists will have the opportunity to further develop their proposals after an artist orientation and site visit. Renderings are not requested at this phase of the project.

DESIGN CONSIDERATIONS

Artists living/working in Wisconsin, ideally in Madison, are eligible to submit qualifications. The selected artists will work with the MPAP to paint their murals. We are seeking inspiring, colorful, contemporary designs that are site appropriate. No mixed media can be affixed to the walls. The walls will be professionally prepared, cleaned, and primed in advance of the mural painting start date. Advertising, political, or religious content is not permitted.

EQUAL OPPORTUNITY. We are committed to fostering equity, inclusion, and diversity in the arts. The selection panel is committed to equitable opportunities for historically marginalized communities.

GUIDELINES. Artists are expected to:

- Work with MPAP and staff on contracts, approval of project materials, equipment and insurance requirements, mural scope of work, meetings, site visits, and project timeline.
- Submit required paperwork for payment.
- Provide design reviews to the committee, if requested, including up to (2) revision rounds.

HOW TO APPLY. Submit a PDF document including:

- Cover letter explaining your interest in this project and proposed project. (1 Page)
- Up to 3-5 images of recent work/mural work as a (.jpeg) including title of artwork or project, date of completion, location, and dimensions.
- Artist CV/Resume. Include any community engagement experience. (1 Page)
- Artist statement (1500 words or less)
- Three professional references.
